Membership Service Terms and Conditions

FREE FREE WORLD CLUB (“Free Free World”) provides a subscription-based membership service (“Membership Service”) that allows our members to access events and exclusive content via the internet, in exchange for a subscription fee.

These terms and conditions (“Membership Terms”) apply to your use of our services if you have a Membership Service account. By signing up for or using a Membership Service account, you agree to these Membership Terms and our general service terms (“General Terms of Service”), which are incorporated into and form part of these Membership Terms. If you do not agree to these Membership Terms and our General Terms of Service, you may not use the Membership Service. If there is any inconsistency between these Membership Terms and our General Terms of Service, these Membership Terms will prevail.

Free Free World is operated by Free Free Ltd, registered in the United Kingdom under company number 14354463. Our registered address is 14th Floor 33 Cavendish Square, London, W1G 0PW

Our Values

Free Free World is meant to be a safe and welcoming environment. We ask all our members, their guests, and our teams to respect our standards of behavior.

Kindness and Inclusion: We welcome and celebrate diversity, far from judgments on gender, race, religion, sexuality, or physicality. We have a collective responsibility to ensure that racist, sexist, homophobic, or any form of abusive language is not tolerated.

Respect and Boundaries: We aim for our community to be a space in which personal boundaries are met and in which everyone feels respected and equally valued.

Privacy: Our community is a safe space for feeling heard, understood, supported, and vulnerable. We require privacy and confidentiality among all members.

Openness and Support: This community is built to come together and reunite to support one another on our journey of expansion. We aim to bring collective growth and evolution, and cooperation among all members is a fundamental value.

By accepting our terms, you commit to our values. We will make sure that everyone has a positive experience. In case of any unpleasant incident, we kindly require you to promptly inform us. By committing to this, you help us ensure a flourishing and healthy community.

Membership

1.1. Your Free Free World membership (“Membership Service”) will commence on the date stated in your membership confirmation email and will continue until terminated. To use the Membership Service, you must have internet access and provide us with one or more Payment Methods. “Payment Method” means a current, valid, accepted method of payment, as may be updated from time to time, and which may include payment through your account with a third party. Unless you cancel your membership before your billing date, you authorize us to charge the membership fee for the next billing cycle to your Payment Method (see “Cancellation” below).

1.2. We may offer a number of subscription plans as part of the Membership Service, including memberships offered by third parties in conjunction with the provision of their own products and services. Some membership plans may have differing conditions and limitations, which will be disclosed at your sign-up for the Membership Service or in other communications made available to you. You can find specific details regarding your Membership Service subscription by visiting our website and clicking into your account.

Promotional Offers

2.1. We may from time to time offer special promotional offers, plans, or memberships (“Offers”). Offer eligibility is determined by Free Free World at its sole discretion, and we reserve the right to revoke an Offer and put your account on hold in the event that we determine you are not eligible. Recent members of the Membership Service may not be eligible for certain introductory Offers. We may use information such as device ID, method of payment, or an account email address used with an existing or recent membership to determine Offer eligibility. The eligibility requirements and other limitations and conditions will be disclosed when you sign up for the Offer or in other communications made available to you.

Membership Billing

3.1. **Billing Cycle:** Your membership in the Membership Service will start on the day you sign up and will continue for the period of time agreed with you at the time you sign up (“Subscription Term”). The membership fee for the Membership Service and the intervals at which you will be charged will be communicated to you at the time you sign up for the Membership Service and will be charged to your Payment Method on the specific payment date. The length of your billing cycle will depend on the type of membership that you choose when you signed up and will be communicated to you at the time you sign up. In some cases, your payment date may change, for example, if your Payment Method has not successfully settled, when you change your membership plan, or if your paid membership began on a day not contained in a given month.

3.2. Payment Methods: To use the Membership Services, you must provide one or more payment methods that are accepted by us ("Payment Methods"). You agree to make all payments on your payment plan and authorize us to charge any Payment Method associated with your account in advance on a periodic basis in accordance with the terms of your Membership Service subscription until your membership is terminated. You remain responsible for any uncollected amounts. If you dispute any charges, you must let us know within sixty (60) days after the date that we charge you. You are responsible for all taxes associated with your use of the Membership Service other than taxes based on our net income. If a payment is not successfully settled, due to expiration, insufficient funds, or otherwise, and you do not cancel your account, we may suspend your access to the service until we have successfully received payment in full via a valid Payment Method. For some Payment Methods, the issuer may charge you certain fees, such as foreign transaction fees or other fees relating to the processing of your Payment Method. Check with your Payment Method service provider for details.

3.3. Updating your Payment Methods: You can update your Payment Methods by sending us an email at info@freefreeworld.org. We may also update your Payment Methods using information provided by the payment service providers. Following any update, you authorize us to continue to charge the applicable Payment Method.

3.4. Changes to the Price and Subscription Plans: We may change our membership plans and the price of our service from time to time; however, any price changes or changes to your membership plans will apply no earlier than 30 days following notice to you. If we increase the fees for the Membership Service and you don't agree to the change, you may cancel your membership, and we will refund to you any fees paid for a period of your Subscription Term after the date you cancel.

3.5. Automatic Renewal: Subscriptions to the Membership Service will automatically renew at the end of each Subscription Term for the same period of time, until you cancel your membership or we terminate it, in accordance with these Membership Terms or our Service Terms. We will contact you before your current Subscription Term ends to let you know that your membership will automatically renew if you don't elect to cancel it and to give you the opportunity to cancel it.

Cancellation

4.1. Cancellation Policy: You can cancel your subscription at any time, and you will continue to have access to the Membership Service until the end of your Subscription Term. Subject to section 4.2 below, all payments in respect of your access to the Membership Service are non-refundable. To cancel, go to the "Account" page and follow the instructions for cancellation. If you cancel your membership, your account will automatically close at the end of your current Subscription Term.

4.2. Cooling-Off Period: If you are a consumer in the European Union or the United Kingdom, consumer laws give you a right to change your mind and cancel your Membership Service within 14 days of the date your Subscription Period started ("Cooling-Off Period"). If you wish to exercise this right of cancellation, you must inform us of your decision within this Cooling-Off Period by contacting us at info@freefreeworld.org. If you cancel your

Membership Service within your Cooling-Off Period, you must pay us for the period of your Subscription Term up until the time you tell us that you have changed your mind. We will refund the subscription fees paid to us, less an amount to compensate us for the period of your Subscription Term before you canceled your subscription (we calculate this as a daily rate based on the fees for the entire Subscription Term). We will make this refund no later than 14 days after the day on which you told us you were canceling your subscription, using the same payment method as you used to pay your Membership Service fees.

4.3. Termination by Free Free World: We may terminate or suspend your Membership Service, or stop providing all or any part of the Membership Service, at any time in our discretion, with or without notice. If we suspend access to your Account generally under our General Terms of Use, such suspension or termination will automatically suspend or terminate your Membership Service. If we suspend or terminate your Membership Service for any reason except your breach of these Membership Terms or our General Terms of Use, we will refund any fees paid under your payment plan that relate to the period after the date the termination takes effect, or we will suspend payment under your payment plan until your Membership Service is reinstated (as applicable).

Privacy and Governing Law

Privacy: Free Free World is committed to protecting your privacy. Please review our Privacy Policy, which also governs your use of the Membership Service, to understand our practices. By using the Membership Service, you agree to the collection, use, and sharing of your information in accordance with our Privacy Policy.

Governing Law: These Membership Terms and any dispute or claim arising out of or in connection with them or their subject matter, whether of a contractual or non-contractual nature, will be governed by and construed in accordance with the laws of England. The parties irrevocably agree that the courts of England and Wales will have exclusive jurisdiction to settle any dispute or claim arising out of or in connection with these Membership Terms.

Frequently Asked Questions (FAQs)

Who is part of FREE FREE WORLD? FREE FREE WORLD's members come from all walks of life, including entrepreneurs, leaders, parents, artists, spiritualists, and change agents in communities around the world. While members may have different roles in life, goals, and cultural backgrounds, we all stand for freedom.

Can I try out an event before subscribing? You can register for an event if you are a member of our community or have been invited as one of their guests. As a guest of one of our members, you will not need to wait for approval of your application, but you will be asked to subscribe for a monthly membership to access the event. During this month, there will be a trial period, and at the end of the 30-day period, you will have a free 30-day cancellation policy, so you can become a member and cancel within this window with no charge. At the end of the trial period, we reserve the right to confirm or end your application.

What is the cost of membership? The standard cost of membership is \$33 per month. However, many people who have the financial capacity choose to give more and can multiply this amount at checkout by choosing to pay more than one monthly fee. This supports the furthering of the mission and contributes to our scholarship fund for student grants. We also offer a leader membership for \$220 per month, which includes participation in our leadership committee and more. For students and individuals needing financial support, we offer a membership for \$11 per month.

How do tickets to events work? All members are eligible to buy tickets to events they want to attend. Tickets range from \$25 to approximately \$200 (for a formal 3-course dinner) and vary depending on the city, type of event, venue, and guest speaker. Galas, retreats, and special experiences can have different prices. All tickets will be launched via email, platform, and WhatsApp through a private link, and tickets are available to members on a first-come, first-serve basis.

How will I access the community content? All members will receive access to the online platform and group calls. All other member communication will be done via email and WhatsApp.

Are men part of FREE FREE WORLD? The majority of FREE FREE community members are women; however, we invite men who express interest to join. Events can be attended by everyone unless stated otherwise for gender-specific programs. For specific events, the ticket page will specify women-only events and for others, we will specify men-only events.
